#### 23/23 COUNCIL MEETING MINUTES

#### 24/23 PLANNING APPLICATIONS

**23/03194/FUL** Alterations to the shop frontage of the commercial unit on ground floor of 90 High Street. 90 High Street, Midsomer Norton. **Recommendation** Midsomer Norton Town Council recommended approval as the alterations would be an improvement.

**23/03275/FUL** Erection of single storey front and rear extensions and internal alterations. 120C Charlton Park, Midsomer Norton. **Recommendation** Midsomer Norton Town Council recommended refusal as previous issues had not been addressed, loss of amenity to neighbours and an increase in the footprint of the building.

**23/03032/FUL** Erection of single storey side and rear extension. 16 Prior Close, Midsomer Norton. **Recommendation** Midsomer Norton Town Council had no comment

**23/03048/VAR** Variation of condition 10 (plans list) of application 23/00462/VAR to revise location of Plot 9 boundary wall and then associated landscaping (variation of conditions 4, 5, and 8 of application 21/00971/RES (Erection of 40 dwellings, provision of public open space and associated works – (Approval of reserved matters with regard to phase 3 of outline application 18/02095/OUT)). Parcel 2000 Silver Street, Midsomer Norton. **Recommendation** Midsomer Norton Town Council recommended approval as there were no reasons for objection.

**23/03315/TCA T1** – Portuguese Laurel, remove 1 lower limb and reduce canopy by 2m, to manage size and available space. 20 Rackvernal Road, Midsomer Norton **Recommendation** Midsomer Norton Town Council recommended approval.

**23/03372/TCA** To dismantle block of conifer trees at the end of the garden approximately 4. To dismantle silver birch. To dismantle small conifers in shrubbery. 3 Excelsior Terrace, Midsomer Norton. **Recommendation** Midsomer Norton recommended approval.

# 25/23 PLANNING APPLICATIONS – Responses to be noted from BANES

**22/03580/FUL** Application for 'enabling works' in preparation for the Policy SSV4 site redevelopment including demolition, groundworks, flood mitigation and formation of 2m footpath along Station Road frontage. **Decision** B&NES refused the application. The Town Council would like to note they recommended approval and BANES disagreed and decided to refuse the application.

**22/00449/RES** Approval of reserved matters with regard to application 21/01656/OUT (Outline application for the erection on 9 dwellings with all matters reserved except access.). **Decision** B&NES refused the application.

**23/0198/FUL** Erection of single storey rear extension, hip to gable roof extensions, rear facing dormer, first floor front extension and internal reconfigurations following demolition of existing conservatory. 31 Park Way, Midsomer Norton. **Decision** B&NES permitted the application.

**23/02271/FUL** Erection of a single storey side/rear extension. 16 Priory Close, Midsomer Norton. **Decision** B&NES permitted the application.

**Appeal APP/F0114/W/23/3318283, planning application 22/02528/FUL** Proposed extension and loft conversion. Somer Lodge, 7 Steam Mills, Midsomer Norton. **Decision** The appeal is dismissed.
