7 - Approval of Grants

Approval of Grant Applications

7.1 - Midsomer Norton & Radstock Dial A Ride

Approval of a grant application from Midsomer Norton & Radstock Dial A Ride for £1,000.

Decision: The Committee RESOLVED to approve the grant application for Midsomer Norton and Radstock Dial A Ride for £1,000.

7.2 - Somerset Farmers Market

Approval of a grant application from Somerset Farmers Market for £1,500

Decision: This was deferred to the next meeting as a couple of points required clarification.

8 - CIL Monies

59C A local council must use CIL receipts passed to it in accordance with regulation 59A or 59B to support the development of the local council's area, or any part of that area, by funding—

(a) the provision, improvement, replacement, operation or maintenance of infrastructure; or

(b) anything else that is concerned with addressing the demands that development places on an area

This change would explain why other town/parish Councils have used CIL money for projects like maintaining or installing new notice boards and signs or funding community hall improvements etc.

Although there may be better projects to consider for CIL, noticeboards, or equipment and decorating costs for the Town Hall can be potential CIL allocations.

The Council could consider using some CIL to fund a feasibility study to create a cycle/pedestrian link connecting the Town Trust's land at Withies Lane with the Silver Street Nature Reserve and Five Arches Greenway off Silver Street.

Many residents have asked about Withies Lane and also independently approached Ward Councillor Sarah Evans who Cllr Mackay is going to meet with on site to discuss the idea.

Decision: Following a discussion Cllrs Gordon MacKay and Shaun Hughes will carry out some research as to the ownership and costs of feasibility studies, these will then be brought back to a future meeting.
